

1. Employability schedule of following manpower will be as under: -

2. Employees should be Indian Citizen with valid Aadhaar Card / Voter Card.

3. No accommodation / room will be provided for day stay for the employees.

4. Employment will be on contract agreement for **11 months** and may be extendable, if agreed by School Administration and Management Committee.

5. Terms and Conditions duly signed by vendors(s) as accepted.

6. Selected vendor will submit Police verification certificate on character and antecedent of their staff once contract is finalized.

7. As per the Govt of West Bengal Circular No 108/Stat/2RW/9/2022/LCS/JLC dated 06 Jul 2022 that minimum wages for an unskilled workers (MTS / Housekeeping / Staff / Cleaner / Sweeper) should not be less than Rupees 8,830/- per head per month in Zone 'B' of West Bengal State.

8. In addition to above minimum wages, 12% and 3.25% are to be added on basic wages as EPF contribution as well as ESI contribution and then service provider service charge is required to be mentioned. Details of financial quote are formulated as under: -

9. Service provider must have registered for Employee Provident Fund as well as Employee State Insurance. JL number of the firm for EPF and Employers Code No for ESI must be quoted in their quotation. Selected service provider has to submit every month deposit of EPS and ESI contribution attached with Army Public School, Sukna then next payment will be released.

10. 02 pairs of New dress / uniform (including shirt, pant, sweater for winter with shoes for gents and salwar suit / sari with shoes, chappals and sweater for winter for ladies) are to be provided to the employee for contract period by the employers.

- (b) Copy of license / certificate under the provision of PSARA Act 2005 and Govt of West Bengal Private Security Agency Rules 2007 issued by Commissioner, Home & Hill Affairs Department, West Bengal, NABANNA, Howrah with date of validity (Mandatory for security guards / watch and ward staff).
- (c) Copy of Firm's Registration number with State Govt Labour Commissioner's Office of State of West Bengal.
- (d) Copy of Registration of Employee's Fund (EPF) having JL number. Copy of **Statement of such deposits in respect of employee** must be attached as credential.
- (e) Copy of Registration of Employees State Insurance with Employers Code number.
- (f) Copy of PAN card.
- (g) Copy of GST registration.
- (h) Details of company's proprietor / partners and full address printed on Firm letter head with company's contract number and email id printed on it.
- (j) **EMD – Rs 10,000/- (Refundable)** in form of DD in favor of **Army Public School, Sukna** payable at **Sukna**, Dist: Darjeeling, (West Bengal). The EMD of unsuccessful vendors will be returned within one month after opening of bid. EMD of selected vendor will be kept for **11 (Eleven)** month as **Security Deposit** and will be returned on termination of contract without interest.
- (k) **Tender fee- Rs 100/- (non refundable)** in form of DD in favour of **Army Public School, Sukna** payable at **Sukna**; Dist: Darjeeling (West Bengal).
